To the Board of Directors British Columbia Archery Association

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

PURPOSE OF THE ORGANIZATION

The British Columbia Archery Association was formed to perpetuate, foster, and manage the practice of archery and without limiting the generality of the foregoing; to adopt, interpret, and enforce rules for the practice of archery in all its forms; to hold annual tournaments for the purpose of determining the Champions for the British Columbia Archery Association; and to act in general as the supreme governing body in all matters that pertain to archery in the Province of British Columbia, Canada. The Association is registered under the Society Act of British Columbia and is not subject to income tax. The Association is not a registered charity under the Income Tax Act and therefore cannot issue charitable donation receipts.

Note 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Basis of Presentation

The Association prepares its financial statements in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

b) Use of estimates

When preparing financial statements according to ASNPO, estimates and assumptions are made relating to reported amounts of revenue and expenditure, assets and liabilities and disclosure of contingent assets and liabilities. Assumptions are based on a number of factors, including historical experience, current events, actions that the Association may undertake in the future, and other assumptions that are believed to be reasonable under the circumstances. Actual results could differ from those estimates under different conditions and assumptions. Estimates are used when accounting for certain items such as useful lifes of capital assets and impairment of long-lived assets.

c) Revenue recognition

Revenue is recognized when earned, specifically when all the following conditions are met:

- There is clear evidence that an arrangement exists.
- Amounts are fixed or can be determined.
- The ability to collect is reasonably assured.

The Association follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when they are received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

d) Cash and cash equivalents

The Association classifies highly liquid investments with maturity of three months or less from the date of purchase as cash and cash equivalents.

e) Contributed services

Volunteers contribute significant hours per year to assist the Association in delivering its services. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.

f) Capital assets

The capital assets are recorded at cost. Amortization is provided annually at rates and methods over the estimated useful lives as follows, prorated for the number of months of ownership. The estimates of the useful lives of the assets are reviewed every year and adjusted on a prospective basis, if needed.

Impairment of capital assets is reviewed whenever events or changes in the circumstances indicate that the carrying value may not be recoverable. An impairment loss is recognized for the excess of the carrying value over the fair value of the asset, during the year the impairment occurred.

Note 2 FINANCIAL INSTRUMENTS

The Association's financial instruments consist of cash, accounts receivable, and accounts payable. Unless otherwise noted, it is the opinion of management that the Association is not exposed to significant interest, currency, or credit risks arising from these financial instruments. The fair value of the instruments approximates their carrying values, unless otherwise noted.

The Association initially measures its financial assets and financial liabilities originated or exchanged in arm's length transactions at fair value. Financial assets and financial liabilities originated or exchanged in related party transactions, except for those that involve parties whose sole relationship with the organization is in the capacity of management, are initially measured at cost. The cost of a financial instrument in a related party transaction depends on whether the instrument has repayment terms. The Association subsequently measures all its financial assets and liabilities at cost or amortized cost. Financial assets subsequently measured at amortized cost include cash, term deposits, accounts receivable and prepaid expenses. Financial liabilities measured at amortized cost include accounts payable.

Report of the VP-Administration

During the past year, I continued my primary work on promoting the sport of archery through numerous BC Archery Try-it clinics in various indigenous communities around the south coast of BC through a partnership with ISPARC (the Indigenous Sports Physical Activity and Recreation Council), as well as other third party groups like Big Brothers/Big Sisters, Spirit of the a children, Girl Guides, Boy Scouts, Pacific Sport and BC Wheel Chair Sports, and various community groups. I continued to sit on or Chair a number of Committees including the Coaching Committee, the Risk Management Committee, Strategic Planning Committee, and the new Club Engagement Committee which is working to help encourage engagement of our members in BC Archery affiliated clubs and to try to find ways to bring more unaffiliated clubs into the fold. Through this new committee I completed the design and printing of a Club Handbook to assist people looking to open an archery club in their community. BC Winter Games- Provincial Advisor

I have immensely enjoyed my tenure as the Provincial Advisor for Archery to the BC Winter Games. My first experience with the Games was as the Assistant Provincial Advisor in 2018 Kamloops, and then I moved right into the Provincial Advisor role for the next 3 Games. Over these 4 Games, BC Archery has improved their profile with the Games Society. Our 'report card' has now reached the highest scores possible, with our sport reaching "Fully Meeting the Criteria" in all evaluation areas.

This has happened because so many people have dedicated their time as volunteers, investing in the betterment of our youth athletes and providing them with opportunities that they may not otherwise have. Without these youth, the sport would have no future. And so many people over the past 4 Games (and well beyond those!!) recognize the value in development and opportunity.

The BC Winter Games are important to our sport because they showcase amateur sport to the public, offer a multi-sport event for young athletes, and provide an opportunity for youth archers to compete among their peers earning medals that they can show off to all their friends.

Because of the many, caring volunteers we have in BC, the Games has recognized BC Archery as one of the go-to sports—when a new sport or Provincial Advisor comes along, the Games uses Archery as an example of what to aim for. We have a partnership with ISPARC to include quota spots for Indigenous Youth. Coaches have furthered their Coaching certifications to meet the minimum requirements—2024 was the first year that we didn't need to ask for an exemption for under-certified coaches. That means that across BC, there are people that believe in our sport enough that they want to further their education and knowledge in order to help more people achieve their goals. We have used the Games as an opportunity to train and certify Judges from all over the Province. And even though we often think our clubs are not producing or attracting enough young athletes, we have been able to bring more than the minimum number of athletes of each gender from each of the Games Zones.

At the Games, athletes learn how to act as a Team, reinforce their knowledge of the rules, and get experience needed to compete confidently at higher level events. The Games are a stepping stone for Canada Winter Games, Nationals and National Team participation.

This year we were able to provide match-play experience by utilizing part of the practice day with an exhibition team event. Often our clubs do not have enough participation to teach match play or team rounds.

Our sport was the first to include Indigenous quota spots (it's a natural fit), and now our Opening Ceremonies are the first of all the sports to have an Indigenous Welcoming Ceremony (okay, that's more because of how the schedule works out, but I like saying that archery is 'first'!)

I am proud of how prominent Archery has become at the Games, and have been honoured to host our Sport Ministers and even the Lieutenant Governor at our Opening Ceremonies.

Sport is an amazing community. Providing a significant experience to a youth-athlete gives them a taste of what an active lifestyle can give them—good health, good friends, good experiences. This was my last year as the PA, and I'm grateful to have been a part of this and to have met so many wonderful people from the Games Society and from other Sport Organizations in our Province. And of course, all of you, my archery family. Thank you for sharing my passion for all areas of archery and striving for the betterment of our sport for all our participants, now and in the future. I look forward to seeing what great things the future will bring.

SOCIETIES ACT (BRITISH COLUMBIA)

Persons qualified to be directors

44 (1) A person is qualified to be a director of a society only if the person is an individual who is at least 18 years of age.

(2) Despite subsection (1), an individual who is 16 or 17 years of age is qualified to be a director of a society if provided for in the regulations.

(3) Despite subsections (1) and (2), an individual is not qualified to be a director of a society if the individual is

- (a) found by any court, in Canada or elsewhere, to be incapable of managing the individual's own affairs,
- (b) an undischarged bankrupt, or
- (c) convicted in or out of British Columbia of an offence in connection with the promotion, formation or management of a corporation or unincorporated entity, or of an offence involving fraud, unless
 - (i) the court orders otherwise,
 - (ii) 5 years have elapsed since the last to occur of
 - (A) the expiration of the period set for suspension of the passing of sentencewithout a sentence having been passed,
 - (B) the imposition of a fine,
 - (C) the conclusion of the term of any imprisonment, and
 - (D) the conclusion of the term of any probation imposed, or
 - (iii) a pardon was granted or issued, or a record suspension was ordered, under the *Criminal Records Act* (Canada) and the pardon or record suspension, as the case may be, has not been revoked or ceased to have effect.
